Simply use the 'Book Settlement' menu option. Add your settlement details including time, date, region and venue. Please view the 'quick guide' for assistance on booking settlements.

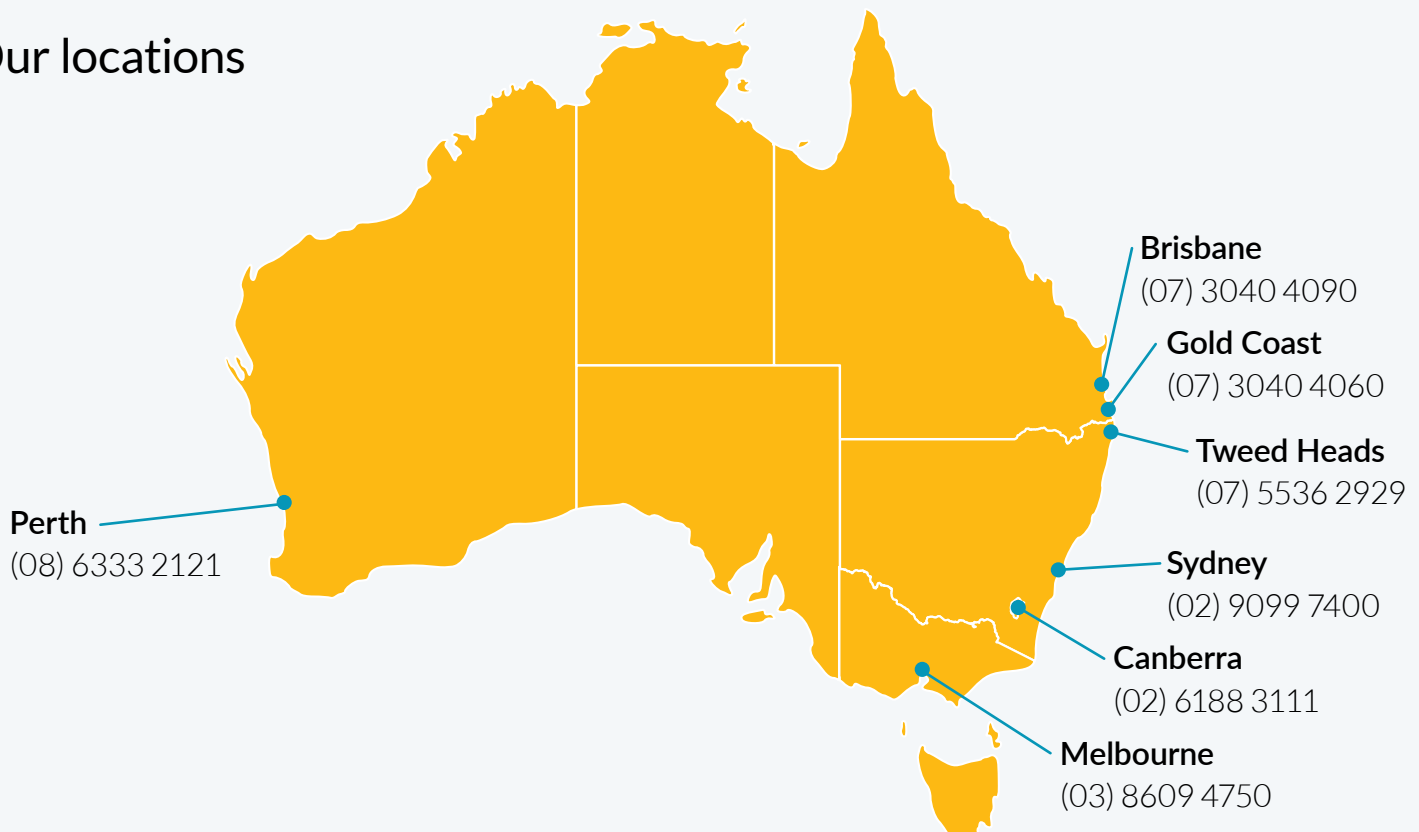
Do the fees associated with settlements, lodging or any other service go back to my practice management system?
